### **Government Retiree Recruitment Campaign**

The Association's national recruitment campaign will be launched in mid-September 2008. This campaign, held every two years, is organized through

Public Works and Government Services Canada (PWGSC) under the authority of the President of the Treasury Board and the approval of the concerned ministers.

Under this program, individuals receiving a pension payment under either of the Public Service, the Canadian Forces or the RCMP superannuation acts, will receive a brochure encouraging them to join FSNA. A separate mailing will be sent later to retired federally appointed judges directly by the National Office.

**Only those** who are **paying FSNA dues through Dues Deduction at Source (DDS)** are **excluded from the PWGSC mail-out. Unfortunately,** the system **cannot** exclude those members who are paying their dues by cheque and, in certain circumstances, individuals who are receiving a pension from more than one source. Although though this fact is explained in the pamphlet, some members still call the National Office or their branch to ask why they received the recruitment material even though they are members.

One way to avoid such possible inappropriate mailings is for you to consider joining the convenient, monthly, DSS dues withholding program. It is automatic, you will no longer have to submit cheque payments to your branch, and automated mailing systems will be aware of your membership. ## **Maple Leaf product Recall – August 2008**

By now you are, no doubt, aware of the national recall of possible, tainted meat products with possible links to a particular Ontario processing plant.

The Maple Leaf corporate Internet website provides the following information to concerned customers:

“...Our voluntary expanded product recall includes all production from the Bartor Road facility in Ontario **(Establishment # 97B)**.

This is a further precautionary measure, notwithstanding the fact that there is no evidence of Listeria contamination in products beyond the production lines originally under investigation.

### ***How do I determine if a Maple Leaf product is part of the recall?***

There are two identifiers, a Crown Seal or an Inkjet imprint, on Maple Leaf products that will help you determine if the product is part of the recall.

Look for the Crown Seal with the establishment number (97B) printed underneath the crown.

If 97B is not printed with the Crown Seal, look for an Establishment Number (Est97B) near the Best Before Date.

All recalled products include the Establishment Number 97B identified through a Crown Seal or an Inkjet Imprint and the best before date associated with the recall.
