FSNA Peel-Halton & Area Branch is a member of the group purchasing program called GAIN. In addition to providing savings on a number of operational needs, we also provide access to some features directly to member's staff and volunteers. One such offering is our Long Distance rates for your home or cell phone use. This plan entitles you to a rate of \$0.039/min anytime, CAN & US, plus great International rates with **no added fees and no contracts**. Billing is calculated using 6 second increments, rather than the typical 1 minute or 30 second segments in other plans – another saving. *GAINtel* has lowered its rates **4 times** in the past 4 years, and will continue to drive down rates for all our clients as the market permits.

We do ask that you make the monthly payments in the form of a preauthorized withdrawal. The reason we do this is that typically your invoice will be for such a small amount that it is not economically feasible to handle payment any other way. The cost for you to send a cheque and us to process it will frequently be more than the bill itself.

Please note: You will receive a monthly statement and have 10 days to review it before the payment due date. We are confident that this is ample time to resolve any issues you may feel are present.
